70th General Service Conference May 16-19 2020 From my Bedroom



Greetings to my friends of Area 52. Thanks for taking time out of your weekend to sit in front of your computer screen, tablet or phone to listen to my experience in participating in the Virtual 70th General Service Conference. I am sure many of you may be thinking that this isn't the ideal way of presenting or hearing about the General Service Conference via technology but here we are doing just that. Hopefully I will be able to cover the "highlights" of the conference with you all in the hour that I am provided. Of course, maybe you are all relieved that it will only be an hour and not the two hours you would have had to listen to me if we were doing this in person. So here is what I saw, felt and experienced.

Saturday May 16, 2020

I woke up early, not knowing what the conference was going to be like. Opening of the 70th GSC was presented by Michelle Grinberg Chair of the board. Roll Call was provided by Greg T. GSO General Manager. I have to say I liked this role call was much more than what I experienced last year. Last year I wasn't able to put a face with the voice. This year when roll call was made the zoom operators "spotlighted" each attendee. So, when our name was called other attendees were able to see who was acknowledging their presence. I really liked that. There are 135 eligible voters during the conference.

Once roll call was presented, we all voted to allow ACM's to be present during the conference as observers. **133 yes 1 no**. ACM's are Appointed Committee Members who help out various committees with experience and knowledge. Not all committees have one. Often times they are an extremely beneficial resource to have in the room.

Greg T. Introduced non-voting staff members of GSO and we voted to allow them to be present during the conference, the vote was **133 yes 0 no**. As with ACM's the knowledge of the staff in the room, voting or not voting can prove to be yet another great resource. Throughout the conference it isn't uncommon to call on a staff or two for clarification of an agenda item or past action that may had occurred to help guide in the decision-making process of a committee. We also voted to allow the "zoom operators" to be present during the conference which obviously needed to happen and the vote was **133 yes 0 no**.

Ray MC provided the opening welcome. Ray is the Delegate Chair of the conference. Tom A. WCR provided the opening key note address. I felt that Tom's address to the conference set a tone for all the committees to really address their "needs vs. wants" while deliberating on what to advance to the Conference Floor, to the 71st GSC or to take no action on. As I have stated in early reports to our Area, Tom was a wonderful example for me. Tom was always principled in his role of the WCR Trustee and in my opinion well respected because of it.

After the key note address ended we were given a short break and were instructed to go to our separate rooms to start our committee deliberations. My committee met for the entire time we were allowed to meet, which was 3 hours and I felt everyone on the committee came to work and work we did. What an experience. I will share more later in my report about the committee work.

Sunday May 17, 2020

I attended the Serenity meeting again today and I felt that it was equally as spiritual as the day before. I felt the Chair and Co-Chair of this meeting ran a fantastic meeting. Each day they had a reading that we could share on which I thought was a great idea. Today's reading was "Once we have placed the key of willingness in the lock and have the door ever so slightly open, we find that we can always open it some more." Twelve Steps and Twelve Traditions P. 35

I had the honor of opening the second day. I was still nervous even though I didn't have to stand up in front of the whole conference. Leslie Backus Class A trustee presented the Finance report. (around the picnic table) The slide presentation that she shared with us will be available in Dropbox once it is revised and updated. Although the 7th tradition proved to be generous this past year it doesn't take away from the fact that there have been some large expenditures that took place causing a grim outlook financially for GSO. I will attempt to highlight some of them.

The new ERP system that was developed has been one source of funds that were spent that was not budgeted. As you have all been aware over the last year the system has not been up to speed as quickly as everyone had hoped which in turn stalled a lion share of the work our registrars do with group records. The GSB and GSO are aware of the frustrations this has caused the fellowship and are working diligently to address these concerns. The 8th floor renovation has also been an unforeseen project that has cost a lot of money. When they started the renovations, they discovered asbestos and that needed to be extracted which added to the budgeted amount. When the book "Our Great Responsibility" was published it was projected to have a lot more sales than it actually had. A supply of books was printed and they missed the projection by approximately 70,000 books. Of course, the closing of the GSO due to the COVID 19 pandemic has not been favorable for the budget either.

I want to also add that we currently really don't know where we sit regarding our "bottom line" as the audit continues to take place at this time which was delayed when NY was closed down. A follow up Zoom meeting for all conference attendees is being planned at this time to provide everyone updated numbers. It is not known when this will happen but when it does, I will be sure to provide an updated financial report once I receive it. Unfortunately, I don't believe it will happen until sometime in June.

Elections West Central Regional Trustee

After a short break was provided, we were ushered into separate rooms to conduct our elections for the West Central Regional Trustee vacancy as well as Western Canada Regional Trustee vacancy. WCR went first. The chairs for the election process were fantastic but I would say that I was a bit disappointed they didn't tell us any jokes from our literature as Tom A. did when he chaired elections last year. However, to be fair the election results were returned rather quick with the zoom election process that was developed by GSO staff and the "zoom operators". Those who participated in the vote were the eight WCR delegates, four members from the Trustees committee and four members from the nominating committee. Those eight members were selected through a random selection process through an excel program. Sixteen members of the conference voted for the WCR Trustee. The seven delegates who had a nominee from their area had two minutes too present their candidate.

The voting followed the 3rd Legacy voting procedure. You have all been informed Mike L. was chosen as the next West Central Regional Trustee.

We did however have some very good participation and I left once again knowing that there are a group of Panel 70 Delegates who will represent A.A. very well.

Monday May 18, 2020

Today's reading was "The spiritual substance of anonymity in sacrifice". Twelve Steps and Twelve Traditions P. 184.

The opening was presented by Brian T. Delegate from the Chicago Area.

Greg T. GSO manager went over How the conference operates before we started the day. This covered the "rules" of the conference. All eligible voters voted to agree that this was how we would conduct the business the next two days, yes-130 no-1

I wasn't so much nervous about the process as I was more nervous about the lack of time. Prior to the start of the committee work we all sent texts to our group and wished everyone luck in presenting their committee's work. I really felt a sense of camaraderie with each and every one of them.

Treatment and Accessibilities

Conference Committee on Treatment and Accessibilities Virtual Conference (via videoconferencing) May 5,2020-5-6:00 p.m. May 16,2020-1:30-4:30 p.m.

The Conference Committee on Treatment and Accessibilities met separately two times following the Joint Meeting with the trustees' Committee on Cooperation with the Professional Community/Treatment and Accessibilities on Tuesday, May 5, 2020. The committee accepted the report of the trustees' committee and considered the following agenda item:

A. Discuss the report on the review of materials related to Bridging the Gap activities.

The committee <u>recommended</u> that the pamphlet "Bridging the Gap" be updated for currency and inclusion to reach a broader scope of treatment settings about temporary contact services, and that a progress report or draft be brought to the 2021 Conference Committee on Treatment and Accessibilities. **Yes-122 No-12 (passed)**

- The committee suggested that the trustees' C.P.C/T.A. committee develop a Bridging the Gap Committee Workbook and provide a progress report to the 2021 General Service Conference. The committee suggested that the shared experience included in the workbook include a list of BTG temporary contacts available from G.S.O.
- The committee reviewed the progress report, "Review of Bridging the Gap Materials," and felt it met the goal of the 2019 committee consideration. The committee suggested that rather than combine Bridging the Gap related service materials, the trustees' C.P.C./T.A. committee consider updating existing service materials to reflect the suggested language updates for currency and inclusion. The committee expressed support for use of a "Question and Answer" style in the content across the range of Bridging the Gap related items. The committee also expressed support for the sample version of "A.A. Guidelines: Bridging the Gap/Temporary Contact Committees" included in the report.
- The committee reviewed the progress report on updating the pamphlet "A.A. for the Older Alcoholic." The committee noted that the submitted stories did not indicate a broad and diverse representation of

A.A. experience and suggested a reopened call for stories based on the following experiences provided by trustees' C.P.C./Treatment and Accessibilities Committees:

- ➤ Ethnic, cultural and LGBTQ communities ➤ Lifestyle diversity ➤ Got sober later in life
- ➤ Veterans from the Vietnam War or later ➤ Hearing loss or mobility issues ➤ Online or telephone A.A. meetings ➤ Dementia or Alzheimer mental health issues ➤ Spiritual pathways
- The committee reviewed the Treatment Committee Kit and Workbook and forwarded a list of suggestions to the trustees' C.P.C./Treatment and Accessibilities Committee.
- The committee reviewed the Accessibilities Kit and Workbook and forwarded a list of suggestions to the trustees' C.P.C./Treatment and Accessibilities Committee.

The committee elected Bill L., delegate for Area 46, New Mexico, chairperson; and Marilyn F., delegate for Area 20, Illinois, alternate chair.

Grapevine

Conference Committee on Grapevine Virtual Conference (via videoconferencing) May 7, 2020 - 7 - 9 p.m. May 16, 2020 - 1:30 - 4:30 p.m.

The Conference Committee on Grapevine met separately two times following the Joint Meeting with the AA Grapevine Corporate Board on May 7, 2020 and received reports from the board chairperson and the publisher and considered the following agenda item:

A. Consider a request to change the name of the Conference Committee on Grapevine to the Conference Committee on Grapevine and La Viña.

The committee <u>recommended</u> that the name of the Conference Committee on Grapevine be changed to the Conference Committee on Grapevine and La Viña. **Yes-130 No-4 (passed)**

- The committee considered a request to change the language of the first sentence of the A.A. Preamble as follows: "Alcoholics Anonymous is a fellowship of people who share..." and took no action.
- The committee also discussed making suggested changes to the A.A. Preamble for gender neutral pronouns. The committee requested that the Grapevine Board consider developing examples of generalized language options and that a progress report or draft versions be brought back to the 71st General Service Conference.
- The committee agreed to forward to the AA Grapevine Corporate Board the suggestion that Grapevine produce in the year 2021 or later:
 - 1. Step Three Turning It Over (working title) Previously published stories from the pages of Grapevine by A.A. members about their various experiences with Step 3.

- 2. Character Defects Steps 6 & 7 (working title) Previously published stories by A.A. members about their experience with Steps 6 and 7, from the pages of Grapevine.
- The committee agreed to forward to the A.A. Grapevine Corporate Board the suggestion that Grapevine produce the following La Viña books in the year 2021 or later:
 - 1. AA and Families in Recovery (working title) Spanish-speaking A.A. members share experiences about how drinking affects the whole family and how A.A. helps repair them, from the pages of La Viña.
 - 2. Old-timers Stories (working title)

Long-time Spanish-speaking A.A. members share their experience, strength and hope, from the pages of La Viña.

- 3. Twelve Steps (working title) Spanish-speaking A.A. members share stories of experience with A.A.'s Twelve Steps, from the pages of La Viña.
- The committee discussed a request for AA Grapevine, Inc. to establish an Instagram account in line with the Twelve Traditions and encouraged them to continue with their planning. The committee suggested that the Grapevine Board provide additional information on implementation, anonymity, security, affiliation, outside contributions, privacy and promotion and bring a progress report back to the 71st General Service Conference.
- The committee discussed ways that AA Grapevine could get feedback on which new book topics to publish. The committee suggested an annual survey in English, Spanish and French be utilized to get input from the Fellowship.

The committee agreed to forward the following to the 71st General Service Conference:

- 1. Review progress report on AA Grapevine Workbook revisions.
- 2. Review progress report on actions taken from the findings of the A.A. Grapevine Fellowship Feedback Survey.
- 3. Consider a request to develop an A.A. Grapevine pamphlet on how the AA Grapevine can be utilized to carry the A.A. message.

The committee elected Ruth L., delegate for Area 87, Southwest Quebec, chairperson; and Jerry S., delegate for Area 08, San Diego/Imperial California, alternate chairperson.

Finance

Conference Committee on Finance Virtual Conference (via videoconferencing) May 11, 2020 – 7-8 p.m. May 14, 2020 – 8 - 9 p.m. May 16, 2020 – 1:30 - 4:30 p.m.

The Conference Finance Committee met once before and twice after the Joint Meeting with the Trustees' Finance & Budgetary Committee on May 12, 2020. The committee accepted the report of the trustees' committee and considered the following agenda item:

- A. Review the pamphlet "Self-Support: Where Money and Spirituality Mix."
- 1. Consider a request to revise the pie chart percentages on page 12.
- 2. Consider draft language related to the "virtual basket."

The committee <u>recommended</u> that the draft language related to the "virtual basket" be included in the pamphlet "Self-Support: Where Money and Spirituality Mix." The language reads:

Q. Some members of our group wanted to pass a "virtual" basket – to collect Seventh Tradition contributions digitally. How could we do this?

A. A number of groups have utilized digital payment platforms as an adjunct to passing the basket in the conventional sense in order to provide opportunities for cashless contributions. There are different payment platforms to facilitate this service and it is up to the group to determine which one to use. Some groups have found that a smartphone app-based payment platform is the most efficient, seamless and minimally disruptive solution for providing a digital contribution. Experience suggests that the treasurer is a likely choice to handle digital contributions, though some groups add more than one trusted servant to share the responsibilities or create a new service position to inform the group about digital payment options and assist other group members who are interested in contributing this way.

The Conference Committee on Literature met separately three times following the Joint Meeting with the trustees' Committee on Literature on May 2, 2020. The committee accepted the report of the trustees' committee and considered the following agenda items:

The committee <u>recommended</u> that the updated draft video of "Your General Service Office, the Grapevine and the General Service Structure" be approved. **Yes-131 No-2 (passed)**

• The committee considered if proposed agenda items for plain language, simplified language, accessible translations and large print versions of the book Alcoholics Anonymous, as well as workbooks to help study the program of Alcoholics Anonymous, can be addressed with a common solution.

The committee requested that the trustees continue to explore this topic. The committee requested that the trustees' make available to the Fellowship, as soon as possible, in Spanish, English and French, the presentation "The Big Book: Researching Issues, Possible Tools and Access (70th General Service Conference 2020)" that was presented to the committee during their May 2, 2020 agenda reduction meeting. The committee noted the importance for the Fellowship to be informed about the nature of the accessibility challenges with regard to A.A. literature.

The committee requested that a progress report be brought back to the 2021 Conference Committee on Literature.

- The committee reviewed the progress report regarding safety and A.A. to be included in Living Sober and "Questions and Answers on Sponsorship." The committee requested a review of the draft language be taken with accessibility in mind as it relates to reading level. The committee requested that a progress report or draft pamphlet be brought back to the 2021 Conference Committee on Literature.
- The committee discussed a draft update of the pamphlet "The Twelve Traditions Illustrated" and noted the accessibility of the language in terms of reading level as well the extent of work done on the current version of the update.

The committee noted that through the process of updating this pamphlet, the final draft update is a distinct item from the original version of "The Twelve Traditions Illustrated," addressing a different audience and serving a different purpose.

The committee forwarded to the trustees' Literature Committee suggestions on the draft update which the committee considered a new piece of literature on the Twelve Traditions. The committee requested that a progress report or draft pamphlet be brought back to the 2021 Conference Committee on Literature.

- The committee discussed not retiring the existing version of the pamphlet "The Twelve Traditions Illustrated" and requested that a written description be provided by the trustees' Literature Committee explaining how an existing version of a literature item might remain in publication after a revised, updated version has been approved, and requested that a report be brought back to the 2021 Conference Committee on Literature.

Committee consideration:

• The committee considered a proposed process for the equitable distribution of Conference committees' workload and noted that the trustees' General Service Conference Committee made significant progress on this complex challenge and further that the proposed process selected by the committee is the appropriate option. The committee agreed that the proposed process would help ensure an equitable distribution of the Conference committees' workload and noted that the Proposed Agenda Item Submission Form would bring much needed structure and clarity to the process.

- The committee reviewed and accepted the 2019 trustees' Public Information report on the current status of Google AdWords/Grants and requested that a progress report be brought back to the 2021 Conference Committee on Public Information.
- The committee reviewed and accepted the report of the status of the 2020 Public Information Comprehensive Media Plan. The committee looks forward to reviewing the new architecture being developed and suggested that social media, video/audio content, and accessibility to the A.A. message continue to be a priority in comprehensive media plan discussions.

The committee also expressed that in light of the recent Coronavirus pandemic it would be helpful to include information as to the many formats in which alcoholics find and carry the A.A. message. The committee looks forward to reviewing the two draft PSAs at their 2021 meeting.

• The committee reviewed a request "to create a new form of communication" to address anonymity on social media. The committee suggested that the trustees' Public Information Committee continue to discuss this request and that preliminary information be gathered before moving forward.

Information to gather:

- o Shared experience from the Fellowship on how A.A. members adhere to anonymity Traditions on various social media platforms.
- o Suggested safety and etiquette while using social media.
- o Anonymity on video meeting platforms.

While the committee recognizes that A.A. literature on anonymity is available ("Understanding Anonymity," A.A. Guidelines on Internet, etc.) the committee noted that the content is dated and does not accurately reflect current technology or the Fellowship's experience. Specific, updated material is needed and the consideration that a video service piece to communicate this sharing might be explored.

The committee requested that the trustees' Public Information Committee continue these discussions and that a progress report or draft proposal be brought back to the 2021 Conference Committee on Public Information.

• The committee discussed a request to develop a plan to create an A.A. podcast. The committee suggested that G.S.O. explore the development of a draft plan to create a G.S.O. podcast to be brought back to the 2021 Conference Committee on Public Information.

The committee suggested that information such as function, target audiences, participation, possible episode topics and an implementation plan be included.

- The committee reviewed and accepted the trustees' Public Information Committee report on the A.A. Membership Survey. The committee noted it was encouraged by some of the findings by the survey professional and asked that the trustees' Public Information Committee continue to explore this topic. The committee also suggested the exploration of a possible digital questionnaire feedback form be part of their discussions.

- o Include more short content communication templates to carry the A.A. message to the public.

The committee considered the following agenda items:

A. Consider amending a sentence in Article 4 of the current Conference Charter.

The committee <u>recommended</u> that the sentence in Article 4 of the current Conference Charter which currently reads:

It will be further understood, regardless of the legal prerogatives of the General Service Board, as a matter of tradition, that a three-quarters vote of all Conference members may bring about a reorganization of the General Service Board and the directors and staff members of its corporate services, if or when such reorganization is deemed essential.

Be amended to read:

It will be further understood, regardless of the legal prerogatives of the General Service Board, as a matter of tradition, that a three-quarters vote of all Conference members **participating in the vote** may bring about a reorganization of the General Service Board and the directors and staff members of its corporate services, if or when such reorganization is deemed essential.

Yes-122 No-11 (Michelle Grinberg passed the Chair responsibility to Greg T. as she was in the minority and she wanted to express her minority opinion) There was minority voice that was heard and after several minority opinions were heard there was a motion to reconsider the vote as someone wanted to change their vote. A vote to reconsider was taken with Yes-76 and No-58 which meant we went back to discussion and a lengthy discussion ensued. The wording of this sentence needed to be changed to keep it uniform with Bill W's essay regarding the potential restructuring or censure of the General Service Board. As we were approaching the 45-minute mark which would have meant this recommendation would have been sent to the 71st GSC the question was called with a vote of Yes-118 No-15. Vote on the original recommendation passed with Yes-96 and No-33.

Committee considerations:

The Conference Committee on Cooperation with the Professional Community met separately two times following the Joint Meeting with the trustees' C.P.C./Treatment and Accessibilities Committee on April 29, 2020. Committee considerations:

- The committee discussed the request to discontinue the pamphlet "A.A. in Your Community" and took no action. The committee noted that this pamphlet is vital to local C.P.C. committee work to introduce A.A. to professionals and that the title defines A.A. as a community resource. The committee also noted that an update to the language and style is needed.
- The committee requested that the trustees' C.P.C./Treatment and Accessibilities Committee explore ways to update content of the pamphlet "A.A. in Your Community" with a focus on modern professional settings and consider those who consume content in various formats. The committee suggested the following items regarding modern digital resources be considered such as:

- ➤ A.A.W.S. LinkedIn page
- > Space to leave local contact information

- The committee reaffirmed its desire that future changes and updates, which amount to additional page content, be vetted through the Conference process.

- Content on the LinkedIn page, intended for professionals who help alcoholics, should be modernized, and reach different settings.

- Continue an ongoing consideration of other platforms, as needed, to sustain the A.A. message to professionals as times change.
- Consider posting content on the LinkedIn page that describes the role of a nonalcoholic trustee.
- Consider posting videos and webinars on the LinkedIn page about C.P.C. committees, which are intended to introduce A.A. and to share ways that A.A. can cooperate with professionals.

International Conventions/Regional Forums

Conference Committee on International Conventions/Regional Forums Virtual Conference (via videoconferencing) May 1, 2020 – 7 - 9 p.m. May 16, 2020 – 5:30 - 6:30 p.m.

The Conference Committee on International Conventions/Regional Forums met separately two times following the Joint Meeting with the trustees' Committee on International Conventions/Regional Forums on May 1, 2020. The committee accepted the report of the trustees' committee and made <u>no</u> <u>recommendations.</u>

- The committee reviewed and accepted a report from the International Convention consultants, Talley Management, outlining the steps taken prior and post cancellation of the 2020 International Convention on March 28, 2020.
- The committee discussed the use of the Lord's Prayer for closing the Big Meetings at the International Convention and had a thoughtful and wide-ranging discussion which included:
- The use of the Lord's Prayer in A.A. meetings can create controversy and support the perception of A.A. as a religious organization.
- ➤ Although the prayer is part of the history of A.A. and is widely used and supported in some areas, it could make some members feel excluded.
- ➤ The benefits of autonomy and keeping the newcomers in mind when selecting how to close A.A. meetings.

- The diversity of our Fellowship and the need for everyone to feel included.
- ➤ Consideration of surveying the Fellowship for a wider sharing regarding use of the Lord's Prayer.
- > Given the international nature of the International Convention, how the Lord's Prayer is perceived in other countries.

The committee agreed that further discussion on the use of the Lord's Prayer as a closing at the Big Meetings of the International Convention would be beneficial and suggested that the 2021 Conference Committee on International Conventions/Regional Forums continue discussion at the 71st General Service Conference.

- The committee discussed ways of encouraging interest in Regional and Local Forums and attracting first time attendees and suggested that the General Service Office consider:
- > Providing options for remote attendance.
- ➤ Providing digital access to Regional Forum materials and presentations (including use of the Meeting Guide App or mobile app).
- ➤ Developing service material for host committees providing shared experience on hosting a Regional Forum and stimulating participation.
- ➤ Developing a "video invitation" from the G.S.B. chair.

Suggestions for implementation at the local area included:

- Early and consistent communication about Regional Forums, including "What is a Regional Forum; no registration fee; what happens at a forum.
- ➤ Involve members at all levels of service; do "sponsorship road trips."
- ➤ Use the Regional Forum video after it is released.

However, in order for this to occur a motion would need to be made to suspend the rules for these 40 minutes. A floor motion was made to approve the slate of directors as presented by the committee. **Yes-91 and No 43**. After further discussion a motion to reconsider was presented with **Yes-70 and No-61**.
