I also get the privilege of serving as the Chairperson of the Serenity Meeting. It is an AA meeting held each morning before the conference begins. Julie C Area 42 Panel 71 Nevada is serving with me as the Secretary-Treasurer. We met via zoom in January to choose our daily topics for the meetings. It has been great fun getting to know her. Our topics came from the AA Service Manual, As Bill Sees It, The Big Book, and

I attended the West Central Regional Alcoholics Anonymous Service Conference in St. Louis Park March 3rd – 6th. Thursday evening, we had a current Delegates Meeting (which our alternates could attend as observers) Friday Morning/Afternoon was the Past and Current Delegates sharing sessions (Rachel also was able to attend this with me). Experience was shared and helpful tidbits of information were passed onto those of us heading to NY. The conference started at 7pm Friday night. The weekend had presentations from various areas in the region, breakout sessions, an open speaker meeting with Bob W, our General Manager, sharing his experience strength and hope. There were 4 general service conference sessions where each delegate presented their committee's agenda items. Discussion was had. Sunday was the Past Trustees Sharing/Ask it Basket. We had 4 people from Area 52 there in person. The WRCAASC was offered virtually, and I know we had some from Area 52 that participated in that way. Thank you to Jason G for moderating the breakout Area 52 hosted, Coming of Age: What is the Next Step. Next year the Service Conference is in Nebraska with a location to be determined and in 2024 it is here in Area 52.

Finances:

The Grapevine.: Originally it was thought that there would be a surplus of \$28,000-\$29,000. However, that became a deficit of \$29,000 due to some late billing that resulted of transitioning from one vendor to another (invoices came 6 months late from a vendor). The initial budget was \$324,000 deficit. We also missed out on some revenue due to the Prayer and Meditation book being sold out and backordered. In 2022, they are looking for a surplus of \$23,000. If you don't have a Grapevine subscription yet, you should. ©

AAWS: Contributions on the year were \$10,782,000 – the highest annual contributions total in the history of the General Service Board. 23% of the contributions were received online.

Gross literature sales for 2021 were \$11.7 million. \$2.5 million more than 2020.

Expenses:

Payroll and benefits were at \$9.3 million (\$7 million less than last year). Of that, there was \$6.2 million related to the retirement program offering (VRIP) We were \$700,000 under where we would have been had the VRIP not happened.

Data automation and website expense was \$626,000.

Facility and equipment expenses were \$2.2 million.

Total operating expenses were \$15.6 million which is 99% of the budgeted amount.

The operating surplus was \$1.8 million. Compared to a budget of \$1.1 million. 2020 had a deficit of \$5.3 million. The Reserve Fund went down to 7.9 months. It was back up to 8.5 months at the end of the year. The 2022 budget will struggle with activity carry-overs from conference actions and reopening of the office. Most of the surplus funds will go to cover that. \$250,000 has already been returned to the Reserve Fund.

There are some requests of the fellowship:

There's a Request for Shared Experience: "Inside" Sponsorship. The trustees' Committee on Corrections is requesting shared experience on the methods by which A.A. members on the outside sponsor members inside correctional facilities. This request is to address an unmet need for sponsorship of A.A. members in custody. Once compiled, this can be added to corrections service material. There is a questionnaire that can be filled out and returned by June 30, 2022, to: corrections@aa.org. You can find it in the What's New tab on AA.org. Go to AA.org and scroll all the way to the bottom and click on What's New.

I sent out an email to the Area 52 committee about the ARMED FORCES MEMBERS INTERVIEW PROJECT The Trustees' Committee on Cooperation with the Professional Community/Treatment and Accessibilities is initiating the production of more interviews from members of the United States and Canadian Armed Forces. The goal of this effort is to improve A.A.'s outreach and identification with members of the U.S. and Canadian military. A major part of this work will be the production of several audio/video products where individual A.A. members who are currently serving or recently retired will share their experience with particular emphasis on recovery in A.A. while serving in the military. We are looking for A.A. members who are willing to be interviewed for this project. We would like to have representation from all Services from Canada and the U.S. The aim is to have recovered A.A. members from all ranks, across the spectrum of age, gender, orientation and varied operational experience speak to what it is like to recover and stay sober while serving in the military. Topics which we hope to highlight would likely include but not be limited to: staying sober while deployed, perceptions of prejudice toward sober people, fears of negative impact on a person's career if they become a non-drinker and dealing with stresses and psychological impacts unique to military deployments and experiences. We're also looking for A.A. members who wish to help find those who might be good candidates to be interviewed.
